### Membership Terms

1. Payment of the joining fee and the current month's prorated fees must be received on the day of sign up. On the first of every month, Members will be billed and their card on file will be charged.
2. Primary Member may choose to pause their membership for half monthly price hold + tax for each calendar month. Primary members would need to notify Jupiter Tennis Center in writing by the 25th of the previous month. In case of illness or travel, membership package can be put on hold once for a maximum of three consecutive months in a rolling 12-month window with a doctor's note or proof of travel. At the end of the three months the membership would return to its pre-hold status and be charged according to the current prevailing membership dues and rules.
3. Jupiter Tennis Center reserves the right to discontinue the sale of any listed membership options or special offers at any time. The joining fees and monthly dues are subject to change. All applicants, including those on the waiting list, will be subject to those fees, dues, changes, and conditions of membership in effect at the time membership is accepted.

As Primary Member, I further understand and agree with the following:

- a) Monthly charges will continue until I give written notice to change or terminate them. The frequency and occurrence of visits/usage has no bearing on monthly membership fees. For an upgrade request, the difference in joining fees between current and upgrade membership type will be charged to card on file.
- b) I am responsible for notifying JTC of changes in my credit/debit card number and expiration date and keeping the card on file current. However, JTC may attempt to roll forward credit card expiration dates, where possible.
- c) I will provide a written notice on or before the 25th of the current month to cancel this authorization for the upcoming months. **If I fail to provide adequate notice, Jupiter Tennis will charge one additional time before the cancellation takes effect and that payment is non-refundable.**
- d) I understand that even if my membership is cancelled, I still need to pay all the dues, charges and penalties/fines incurred until the time my membership is fully cancelled.
- e) I understand that membership rates are subject to change and as a result the amount transferred/charged may change. JTC will notify me in advance of increases in my fees by mail or email. I am responsible for notifying JTC if my address or email changes.
- f) I understand that a 3.5% service charge for the monthly credit card processing may be added to the account each month if the payment is by card, instead of cash or check or Zelle transfer.
- g) It is my responsibility to bring any billing discrepancies to JTC's attention within 60 days after they are processed by my financial institution. After 60 days, I waive my right to dispute such discrepancies.
- h) I understand that at certain times of the week, courts would be prioritized for Junior and Adult lessons, Tennis Socials, USTA and PCL matches, pickle ball play, birthday parties and other such activities and agree as those are essential for our tennis community. I understand that I can participate in those as needed and need to follow the event specific participation guidelines.
- i) All upgrade/downgrade/cancel requests need to be in writing and signed and submitted by only the primary member. I understand that JTC cannot accept any verbal discussions, voicemail, emails, or text messages regarding the ask.

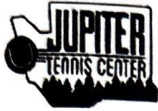
### Payment Authorization
